3. To discuss and approve the conduction of April / May 2020 Online Examinations for the terminal semester students.



6. To discuss and approve the various payments to be made for conducting the End Semester Online Examinations.


The Principal presented the changes in payments to be made for conducting End Semester Online Examinations. The Governing Body members approved the same as given in Annexure-I.
